Meeting Circular 2

As a dozen associations/unions have pre-registered, the ILOAT Reform Rome Meeting is now confirmed.

Being organized on behalf of the Federation of International Civil Servants' Associations (FICSA) by the CERN Staff Association and hosted by the FAO-WFP Union of General Service Staff, the meeting is a sequel to the ILOAT Reform London Meeting which was held September 28th, 2002. Purpose of the Meeting

In view of the decision by the ILO Governing Body at its March 2003 session that consultations with the "clients" of the ILOAT should continue (with a view to submitting modifications to the Statute of the Tribunal before the International Labour Conference in June 2004) and aware of a meeting between the Legal Advisers of the "client" organizations to be held at the ILO on Friday, September 19th 2003, the meeting's aims are:

- to understand the importance of the issue and take stock of the progress made so far;
- to ensure that the views of the staff representatives of the "client" organizations are taken into account and the legitimate interests of staff promoted; and
- to discuss how to arrive at a timely and comprehensive modification of the Tribunal's Statute.

It was originally proposed that the Meeting elaborate a Common Position Paper which would have been submitted to the participants of the ILO meeting for the Legal Advisers of the "client" organizations. However, following discussions with some of you, it appeared that this could be misinterpreted as a confrontational approach by our counterparts and could thus be counterproductive. More importantly, it has now been confirmed that staff representatives can attend the meeting of the Legal Advisers, as part of their organization's delegation, provided they can agree on this with their Administrations. To ensure as effective participation by staff representatives as possible, more time has now been allocated to a presentation of the issues at stake, their importance for staff associations/unions, and how to address the negative reactions of some Administrations to the proposed changes to the Tribunal's Statute.

The Meeting will thus be a unique opportunity for staff representatives to acquire in-depth knowledge of the issue, to better understand the possible reaction of Administrations, and thus prepare themselves for the lobbying efforts they will have to undertake either collectively or within each organization to ensure that the reform is a success. The meeting will also cover other approaches to ensure that International Civil Servants' fundamental rights are adhered to in the handling of disputes.


To prepare the meeting as effectively as possible, every participating Association/Union is invited to discuss with their Administration its comments on the proposed changes to the Tribunal's Statute and to find out if they could participate in the meeting for the Legal Advisers on 19 September.

Arriving at FAO

The Meeting will take place at the Headquarters of the Food and Agriculture Organization of the United Nations, situated on the corner of *Viale Delle Terme di Caracalla* and *Viale Aventino*, as shown on the map on the next page.



Travelling by Underground

Use the blue line, *Linea B*, taking the train in the direction of Laurentina (if coming from the centre of Rome). The stations from the beginning are *Stazione Termini—Cavour—Colosseo—Circo Massimo*. Get off at *Circo Massimo* (as marked in red on the map) and FAO is directly in front of you. If you are staying some distance from the centre of Rome, you may have to change direction (i.e. always using *Linea B* but in the direction of *Stazione Termini*). The stop is always *Circo Massimo*. There is one other underground line in Rome, the red line called *Linea A*. If you find yourself closer to an underground station on the *Linea A*, you will need to cross over to *Linea B* at *Stazione Termini*.

Travelling by Bus or Tram

The best way to find out bus and tram routes in Rome is to go to the website <u>http://www.atac.roma.it</u> where you can give details of your departure point and destination and receive the appropriate itineraries with the bus numbers.


Registration
